7. Consider Proclamation for May as Mental Health Awareness Month

WHEREAS, since 1949, the month of May has been recognized as Mental Health Awareness Month to raise awareness about the importance of mental health care and its impact on the wellbeing of everyone in the community. In Texas, 1 in 5 adults experience a mental health challenge each year. In fiscal year 2022, MHMR Concho Valley served 1,702 adults and 572 children. Mental health care is essential to the health and wellness of each person in the Concho Valley and with the proper supports and resources, those with mental illness can recover and lead productive and positive lives.

WHEREAS, all citizens experience times of stress and difficulty in their lives and they should feel empowered to seek help and resources to manage these times. The rate of depression across the country has more than tripled compared to rates in 2019, and people need support now more than ever. Every person has an important role to play in supporting those with mental illnesses by learning warning signs, talking to affected loved ones, and by fighting negative stereotypes that come with mental health diagnoses.

WHEREAS, we dedicate May to raising awareness about mental health and working to diminish the stigma that surrounds it. During this month, we encourage everyone to treat those with mental illnesses with compassion and to create an open and honest dialogue about mental health with family and friends. Together, we can help everyone get the mental health support they need to get well.

THEREFORE, I, Cary Houston, Chair of the MHMR Concho Valley Board of Trustees, do herby proclaim: MAY as "MENTAL HEALTH AWARENESS MONTH"
