#### 1. Call the meeting to order, invocation, certification of a quorum

At approximately 5:30 pm, Mr. Cary Houston, Chair, certified a quorum was present and called the meeting to order. Jeff Gibson gave the invocation. Dr. Singg was present via zoom.

#### 2. Public comments will be limited to three (3) minutes

No public comments.

#### 3. Employee of the Month for October

Mr. Gregory J. Rowe, Chief Executive Officer, recognized Alyssa Spence as the recipient of the RISE award for the month of October. Ms. Spence is the Center's Community Relations and Outreach Coordinator.

#### 4. Consider the Minutes of the September 28, 2023 Board Meeting

On motion of Mr. McKee, seconded by Ms. Harrison, the Board of Trustees unanimously voted to approve the minutes. Ms. Spieker abstained from voting due to her absence from the meeting. Motion carried.

#### 5. Monthly Report of the Finance Committee

A Finance Committee was not held on Wednesday, October 18, 2023. Patsy Larson, CFO, reviewed the financial statement with the Board.

• Review of the Financial Statement- September – A preliminary report was reviewed. No action taken, information only.

- Review of a change order to the Dr. Lloyd L. Downing Campus Renovations- additional \$12,000 for filling cracks at both parking lots.
- Review of the Employee Health Insurance Group Rates-BCBS provided the Center with an a 24% in rate calendar year 2024 Center staff is working with the Agent of Record to reduce rate increase and review alternative policies.
- Review of the Single Audit Review Issues for Fiscal Year 2022-Reviewed HHSC letter dated September 8, 2023.
- Review of the 1115 Medicaid Waiver Programs Charity Care Pool (CCP) and Directed Payment Program (DPP) the FY2023 CCP Cost Report is due November14, 2023.
- Review of the Chief Executive Director's Expenses- Information only.

#### 6. Consider of the City of San Angelo Annual Allocation for Center Services

On motion of Spieker, seconded by Ms. Kujawski, the Board of Trustees unanimously voted to authorize the Board Chair to sign the agreement in the amount of \$80,000. Motion carried.

#### 7. Consider of the FY 2024-2025 HOME Grant with the City of San Angelo

The grant is \$67,500 that includes a match of \$17,500. On motion of Ms. Spieker, seconded by Ms. Harrison, the Board of Trustees unanimously voted to authorize the Board chair to sign the agreement. Motion carried.

#### 8. Consider the Center's Strategic Plan Scorecard for FY 2023

Greg Rowe, CEO, presented the annual strategic plan report for FY 2023. The report indicated the Center has met most of the objective under the five strategic plan goals. Next steps are to start using the data collected to make performance improvements in the Center; Begin discussion of Commission on Accreditation of Rehabilitation Facilities (CARF) for selected Center programs: Consider and evaluate the possibility of a promotion scheme for selected positions in the Center; and address all unmet, revised, and unaddressed measures. On motion of Ms. Spieker, seconded by Mr. Peterson, the Board of Trustees unanimously voted to accept the report as presented. Motion carried.

He gave a brief report of the IDD Summitt given at the Texas Council Executive Director's Consortium in August.
