### 6. Consider the TIPS Quote for the Dr. Lloyd Downing Behavioral Health Campus Renovations

On a motion of Mr. McKee, seconded by Dr. Davenport-Herbst, the Board of Trustees unanimously voted to accept the bid submitted by JAJ Property Services, LLC, TIPS Contract Number 23010402, in the amount of \$178,700 to be paid out of the Center's fund balance. Motion carried.

### 7. Consider the TIPS Quote for the Purchasing of Office and Conference Chairs

On a motion of Mr. McKee, seconded by Dr. Davenport-Herbst, the Board of Trustees unanimously voted to accept the bid submitted by Total Office Solution of West Texas in the amount of \$50,503.49 to be paid out of the Center's fund balance. Though it is not the lowest bid, it is the lowest bid that provides installation, and it is a local vendor. The Center does not have the availability in its staff to assemble 235 chairs. Motion carried.

## 8. Consider the Request for Bids for Cellular Service and Cell Phones

On motion of Mr. McKee, seconded by Dr. Davenport-Herbst, the Board of Trustees unanimously voted to accept the bid submitted by T-Mobile in the amount of \$37,435.44 to be paid out of the Center's fund balance. Motion carried.

# 9. Consider the Bid for Seal Coat and Striping of Dr. Lloyd Downing Behavioral Health Campus and the Family and Youth Guidance Center

On a motion of Mr. McKee, seconded by Dr. Davenport-Herbst, the Board of Trustees unanimously voted to accept the bid submitted by R&R Construction in the amount of \$36,314.25 for the Magdalen Campus and \$7,987.50 for the Oakes Campus total amount \$44,301.75 to be paid out of the Center's fund balance. Motion carried.

# 10. Consider the FY2024 Operating Budget and Staffing Budget

On a motion of Mr. McKee, seconded by Mr. Gibson, the Board of Trustees unanimously voted to approve the budget with the following: \$14,203.751 projected revenues; \$14,702,970 projected expenses with margin/to reserves \$524,219. The Planning and Network Advisory Committee reviewed the budget, and no recommendations were made. Motion carried.
